\*\*EV Charging Rates are separate from the Buffalo Civic Auto Ramp parking rates; all Transient parkers must pull a ticket on entry and pay the ramp parking fee when exiting.

- The **EV Connect App** must be used to charge at all EV Charging Station's located at a BCAR managed ramp. Download the EV Connect App from your phone's app store.
- Parking spaces marked **Electric Vehicle Charging** can only be parked in while charging your vehicle.
- After plugging in the electric vehicle, you must verify your EV Connect charge session has started successfully before leaving the ramp.
- If for any reason you or the EV does not successfully start a charge session, **DO NOT** leave the vehicle parked in the charging spot.

**Violations to the EV Charging policy will be enforced and violators issued a parking citation.**

- Non-Electric vehicles cannot park in an electric vehicle charging space for any reason whatsoever.
- Electric Vehicle Charging spaces can only be parked in while charging an EV.
- EV's parked in an Electric Vehicle Charging space are required to have an **ACTIVE** EV Connect charging session.
- When you unplug your EV you **MUST** move the vehicle from the EV Charging Space - no exceptions.

- Chargers in a preparing state have not started a charge session and are considered illegally parked.
- Chargers must have an active charging session while the EV is plugged in. This means the payment method used in the EV connect app was successfully charged the pre-authorization amount under EV Connect terms and conditions so that the charger receives the authorization to start the charging session.
- BCAR will at its discretion revoke the right of any individual or EV from using the facilities charging stations due to any deliberate attempts to circumvent this policy or repeated violations.

*Liability is limited as posted in the parking facility and as stated herein. Any and all persons using/operating electric vehicle charging stations waives and releases any claim for injury, damage, or loss resulting directly or indirectly from any action or failure to act by the City of Buffalo, Buffalo Civic Auto Ramps and its employees under this agreement, including but not limited to, any loss of vehicle or contents, or any damage to vehicle by vandalism, theft or accident, damage to any vehicle in its entirety or individual parts, components, materials, batteries. EV station users and parkers are advised not to leave articles of personal property of any value in vehicle and agree not to hold City of Buffalo or Buffalo Civic Auto Ramps responsible for loss of property or damages resulting from loss of property left in vehicle in violation of this agreement. By using any EV Charging station located at a Buffalo Civic Auto Ramps ramp or parking lot you agree that Buffalo Civic Auto Ramps and its employees can unplug your vehicle from the charging station if deemed necessary for safety reasons, violations to policy, or any other reason and will not be held liable for any damage to vehicle resulting from such actions.*
